The meanness, instability, inconstancy of the "crowd" – the people, its inability to understand and feel the conditions of its own life.

The power of the crowd in the service of mafia is blind, unreasonable, unreasoning, serving the left and the right.

Mafia makes suggestions about freedom, equality, brotherhood, justice, pushing towards debauchery, drunkenness, cunning, hypocrisy, violence, robbery and terror.

Terror is carried out in all vertical and horizontal structures of the executive branch.

Terror is carried out in favor of mafia and its representatives from the prosecutor's office, judiciary.

Terror is carried out through the National Revenue Agency, Ministry of Internal Affairs, prosecutor's office, tax services, municipal services and others.

Mafia control the most important factor of public thought – the press and print media, all types of media – especially television, the Internet.

The thought of the crowd moves through the press and the media. The role of the press and the media is to: perceive the needs, convey complaints and reveal the dissatisfaction of the people. The press declares free speech. But this is apparent. News events are managed and controlled by representatives of the mafia.

Speculation is the main form of business and business relations.

Capital is the one that moves the world, moves slavery, which controls industry and trade.

They deliberately complicated and confused the legislation.

Judges do not enforce the law, no one can punish them, no one wants to punish the judges, there is no such institution that would punish them, sanction them, fire them.

Mafiaism and its representatives at the state level create, maintain and support the PROCESS OF GOD'S CHOSEN IN COURT AND PROSECUTOR'S OFFICE.

Judicial acts are issued that distort interpretations, contradict the law and its proper implementation, create precedent law in a judicial system that does not allow such law, create precedent law that grossly violates the laws and rights of individuals and companies, issue contradictory interpretations.

War and oil

The beginning of the oil empires is associated with John D. Rockefeller. In 1870. He created Standard Oil. In 1882, he became the first trust. / unification of many companies under one management/.

Shareholders of forty American companies signed an agreement and entrusted their shares to a supervisory board of nine men. In 1890, the government issued the first antitrust law. Rockefeller moved the main part of the company abroad.

At the end of the 19th century, a remarkable oil industry developed in Russia. The oil fields in Baku were in the hands of the Swedish brothers Robert and Ludwig Nobel. Russian oil production amounted to 600,000 barrels in 1874, and ten years later it reached 10.8 million barrels - about a third of American production. Oil entrepreneurs Bunge and Palashovsky built, with the financial

assistance of Rothschild, a railway line from Baku to Batumi on the Black Sea - the most important oil port. In 1886. The Rothschilds founded the Caspian and Black Sea Oil Company. The distribution is between the four companies - Standard Oil, Royal Dutch Shell, Detergent, the Nobel brothers' company and the Rothschilds'.

The wars in Afghanistan and Iraq are oil.

The creation of the Federal Reserve in 1913

The creation of the Federal Reserve - a private institution that would print US dollars and control real finances throughout the world.

In the USA, the Federal Reserve was founded in 1913.

The largest owners of FED shares are:

1. Rothschild banks from London and Paris.
2. Lazard Brother Bank from Paris
3. Israel Moses Seif Bank from Italy
4. Warburg Bank from Amsterdam and Hamburg
5. Lehmann Bank from New York
6. Khun Loeb Bank from New York
7. Chase Manhattan Bank from New York
8. Goldman Sachs Bank from New York

The value of banknotes printed by the Federal Reserve is 50 - 70 cents. The money in circulation issued by the Federal Reserve banknotes is 263 billion as of 2002. The liabilities of the USA alone are over 4 trillion US dollars as of 2002. The Fed is a private institution.

With the Federal Reserve, the United States is thrown into utopian state debt obligations to bankers. The payment of interest is guaranteed by tax revenues. Where they cannot be paid, the ownership of state banks is transferred to English and/or French banks.

Oil and the First World War

Before the outbreak of the First World War, there was an agreement between Russia, France and Great Britain on how raw materials would be distributed after the end of the war. – “Syke – Picot”

A decisive role in the course of the First World War was played by transport and supplies – the supply of weapons, ammunition and other things to the warring parties.

The October Revolution in Russia

The instigator of the Russian Revolution - Jacob Schiff. Born in 1847. In Frankfurt am Main and grew up next door to the Rothschild family. 1865. He left for New York where in 1875. He started working at the bank "Kun Loeb & Co." in 1885 - became its director - this was on Rothschild's orders. Kuhn and Schiff were members of the lodge.

The American financial circles have been sworn enemies of the tsarist regime in Russia for years, 1904 Schiff

wrote to Rothschild that over the past 5-6 years he had thwarted loans to Russia.

Instead, Schiff arranged for Japan in 1905 three loans to Japan, he aimed at the victory of Japan and social tension in Russia. Rothschild Kuhn Loeb & Co. actually financed Japan as well. In 1914, the conflict with Germany broke out.

Already with the conflict with Germany, the Russian army was weakened.

Lloyd George found that the situation on the Russian front was desperate in connection with the delay in military supplies by five months. There was only one rifle for 6 soldiers.

Tactics of the Jewish lobby to bring Russia to famine and misery by sowing the seeds of unrest, protests, resentment and creating conditions - favorable conditions for the instigators of the revolution. (The soldiers begin to rebel.

Responsible for the supplies is the company "Vickers Maxim" controlled by Sir Ernest Castle, a partner in the transaction of Kuhn Loeb and Co. - a member of the Rothschild family.

Meanwhile, the Jew Alexander Kerensky incites discord in Russia.

Money was transferred in 1917 from the Federal Reserve Bank in New York to the "Rockefeller National Bank" - the only bank in St. Petersburg that was not nationalized / intended for the October Revolution, conceived as early as 1903.

1918 Jews gather in New York for the final outcome of the revolution in Russia - Jacob Schiff, L. Marshall, O.A.V Rosalsky, O.A. Kahn – founder of the Schiff Bank and owner of the New York Times, B. Schlesinger – who met Lenin, Joseph Schlossberg – secretary of the Workers' Union/ M. Paine, David Rinsky and others Barondes.

1920 in the American Jewish magazine of September 10, 2910 the Jewish lobby stated: "The Bolshevik revolution is a kind of echo of Jewish discontent".

Leon Trotsky was living in New York when the emperor was overthrown in 1917. Trotsky left on March 26, 2917 for St. Petersburg on the steamer Christiania with 10,000 US dollars in his pocket, given to him by Rockefeller. Trotsky entered with an American passport that he personally received from US President Woodrow Wilson – a puppet in his hands. On March 19, 1917. Jacob Schiff sends a telegram to the Minister of Foreign Affairs of the Provisional Russian Government Milyukov:

The nephew of Jacob Schiff in the New York Journal American of February 3, 1949. confirms that his relative is Chezhdu 1918 and 1922. his grandfather transferred to the Russian revolutionaries 30 million US dollars, which Lenin later returned paid in the amount of 600 million rubles in gold / equivalent to 450 million dollars / in gold. To Bana Kuhn Loeb and Co.

The banks "Morgan Rothschild, " Lazarus", Barburg" by Sir George Buchanan and Lord Milner,

The American Secret Service of March 6, 1920. in February 1916 - for the first time it is understood that in Russia the incitement of the revolution - a list of names of bankers: Schiff, Kuhn, Loeb and Co., Jerome Handwell, Guggenheim, Max Breithurng –

The emperor actually refuses the Jews to form a central bank in Russia.

The way of preparing the October Revolution is like that of the French Revolution -The first condition is to create conditions for the maturation of an economic crisis that will lead to the destabilization of political power in the country.

The financing of the October Revolution was financed by American banks in 1903. Theodore Roosevelt met with representatives of the "Children of the Covenant", the oldest public Jewish organization.

Napoleon Levy was also present there - the author of the protest diplomatic message that the USA sent to Russia condemning the pogrom on April 19, 2003. in Chisinau.

This message was sent with a signed signature from 30,000 members of the "Children of the Covenant"

1905. the banker of Jewish origin Jacob Schiff - a member of "If the emperor refuses to give our people the desired freedom, then with a revolution we will establish a republic and we will win our rights". Since 1905. The bank Kn, Loeb & Co. began to economically support the Russian Revolution, financing Lenin, Trotsky and Zinoviev.

Two members of the English Pilgrim and the "Round Table" Freemasons Viscount Alfred Milner and Sir George Buchanan - the English ambassador in Moscow - were responsible for distributing the money. The money was provided, in addition to Lazar and his son-in-law Felix Warburg - founder of the Federal Reserve in 1913. And by Hermann Kahn, Mortimer Schiff, Max Breiting, Jerome H. Hanauer, Solomon Guggenheim - all from the "Children of the Covenant".

William Boyce Thompson - director of the Federal Reserve and shareholder in Chase Manhattan Bank - financed the propaganda activities of the October Revolution with one million US dollars

Financing - propaganda - in the media, television, agencies, travel, training, equipment, weapons, printed publications

The October Revolution received the financial support of the German General Staff.

Bank transfers passed through Germany through the trade union "Rhino Westphalia" run by the coal magnate - Kirdorf - the bank "Warburg & Co" in Hamburg and "Speyer" - in Frankfurt, reaching Sweden in Nya Banken and passing through the Jewish "Olaf Ashbers". The Jewish bank "Günzburg" with headquarters in Petersburg also participated. Letter of credit of 40 million gold francs. Soon after, Rockefeller's Standard Oil in New Jersey purchased 50 percent of the huge oil deposits in the Caucasus, although they were officially state property. The way to prepare for the October Revolution was like that of the French Revolution. The emperor actually refused the Jews to form a central bank in Russia. 1804 Napoleon understood the power of those who threaten France - he stopped tolerating Rothschild, for which he paid with his death. Rothschild from that moment on began to finance every coalition against Napoleon.

It was not Wellington who defeated Napoleon, but Rothschild.

Historical evidence of financing and causing the Second World War

1. Loans granted by international financial institutions to Germany 1924 / Dawes Plan / - 1929 Young Plan / in the arms industry of Germany.
2. The rise of Hitler - financial support of Chase National Bank - Rockefeller, Union Bank - Prescott Bush,
3. Economic and monetary reform - developed by Hjalmar Schacht - right hand of J. P. Morgan
4. Hitler's armies with the support of the giants Ford, Chrysler, IBM, Standard Oil, Shell Oil, General Electric, General Motors, Kodak, DuPont, . Most of these companies had subsidiaries in Germany - before and during the war.
5. Without the synthetic fuels of I.G.Farben. thanks to the licenses of Standard Oil from Rockefeller, It was founded in 1925 by Hermann Schmitz with American capital - Paul Warburg - founder of the FED, Max Warburg, Edsel B. Ford, S.E. Mitchell, and Walter Teagle from the Federal Reserve The company in 1941 built the largest chemical plant in Auschwitz, Farben had made secret agreements before the war with the USA, so that their factories would not be bombed 93% of Farben's factories remained undamaged. As well as other factories to

be spared – AEG the German subsidiary of General Electric/.

6. The attack on the Japanese Pearl Harbor, with which Roosevelt declared war on and entered the Second World War, was deliberately provoked by the McCollum Plan. The US imposed severe economic sanctions against Japan. American intelligence was clear about the plan for the attack.
7. On October 19, 1936, the US Ambassador to Germany William Dodd reported to Franklin Delano Roosevelt that Dupont had opened companies in Germany,
8. In December 1933, Standard Oil Company transferred \$2 million to produce a substitute for German fuel.
9. THE BANK FOR INTERNATIONAL SETTLEMENTS BRI provided Hitler with financing, it was established in 1930. In Basel as a bank of banks

After the Second World War, the bankers PREPARED THE MARSHALL PLAN - for the reconstruction of Germany. Again they financed and profited from the loans.

The Cold War and financing,

NATO 1949 – Warsaw Pact 1955

The military arsenal of the Soviet Union until 1945

1944 Stalin officially thanked the USA for the assistance provided against Germany He admits that 2/3 of the Soviet industry was built with the participation of the USA.

The Katyusha rockets are loaded with cordite supplied by an American company, 95% of the Soviet artillery park was produced in large enterprises designed by American companies - Ford Motor Company, Arthur J. Brandt Company, Austin Company, General Electric, Swindell – Dressler - had representatives of Zitko. The Soviet automobile industry GORKI was built by FORD in 1932. 1946 the British government gives the Soviet Union 55 turbojet aircraft, 25 are made by Rolls Royce 30 by Derwent. FIAT enters into an agreement with Rockefeller's Chase Manhattan Bank to build a new Russian automobile plant in Togliatti.
